NOTICE OF PROPOSAL

NOTICE IS HEREBY GIVEN that Wokingham Borough Council, as the Local Traffic Authority in exercise of its powers under Sections 1,2,3,4,5,32,35,45,46,49,53,124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ('the Act of 1984'), Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, proposes to make the above named Order.

The effect of the Order will be:

To introduce the following restrictions on parts of the following roads, as shown on the plans attached to the draft Order:

No waiting at any time restrictions (double yellow lines)

Earley - Blackthorn Close (Plan L39), Mays Lane (Plan M43), Shepherd's House Lane (L37), Rushey Way/Toseland Way (Plans O46 & P46)

Twyford - Colleton Drive (Plans V32 & V33)

Winnersh - Greenacres Avenue (Plan R45)

Wokingham - Hart Dyke Close (Plan X59), Fishponds Road (Plan W56), London Road (Plans Z53 & AA53), Murray Road (Plan W53)

Woodley - Fairwater Drive (Plan O42), Haddon Drive/Rowan Drive (Plans P37 & P38)

Limited waiting restrictions (single yellow lines)

Earley - Dunaways Close (Plan N45), Mill Lane (Plan P47) Shepherd's House Lane (L37)

Wokingham - Caroline Drive (Plan W52), St Helier Close (Plan X58)

To make changes to the operational times of restrictions on parts of the following roads, as shown on the Plans attached to the draft Order:

No stopping on school entrance markings (yellow zig zags)

Wokingham: Easthampstead Road (Plan Z54), Goodchild Road (Plan Z54), School Road (Plan Z53), Seaford Road (Plan AA53)

To revoke the no waiting at any time and no waiting restrictions along Molly Millars Lane, Wokingham (Plan X55) due to the installation of a pedestrian crossing (white zig zags).
