



Allocation breakdown for admission to Secondary School 2025

The following information is based on the initial allocation on 3rd March 2025 for applications received by the deadline of 31st October 2024. This information provides a statement of how places were allocated in line with the published admission arrangements. This information is accurate for National Offer Day but will change once Late applications are considered and responses are received.

Equal preference scheme

Places were allocated using an equal preference scheme. This arrangement allows each preference to be considered individually, taking account of the admissions criteria. Where a child can potentially be offered a place at more than one of the preferred schools the single offer is for the school ranked highest by the parent.

Where the number allocated exceeds the Published Admission Number, this could be due to multiple birth children being allocated to the same setting; a child with an EHC Plan or a looked after/previously looked after child being allocated.

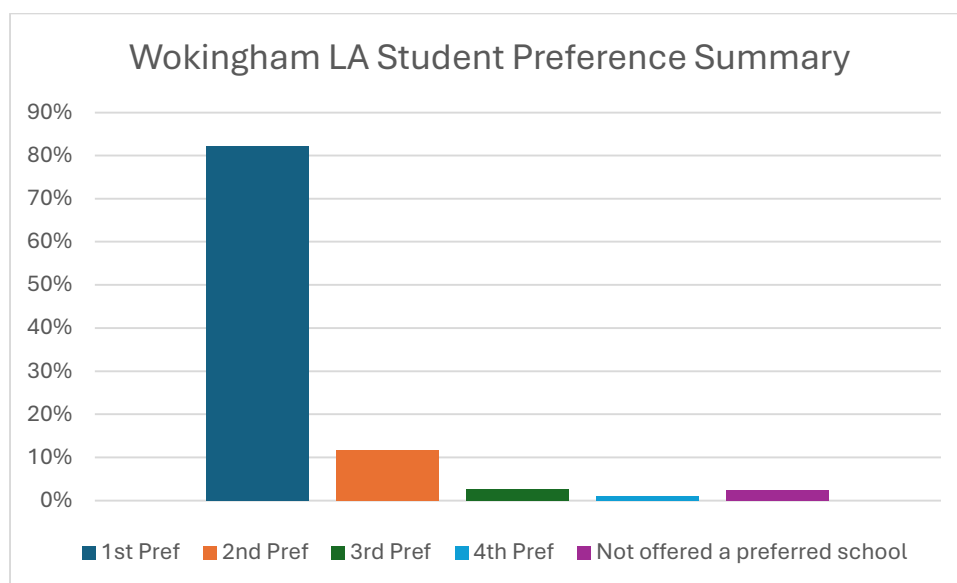

The following chart shows the breakdown of applicants who received their first, second, third or fourth preference school and those who were not offered a preferred school.

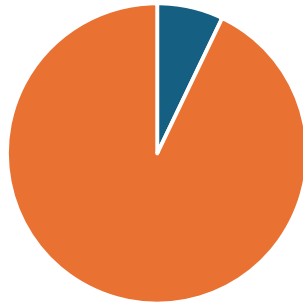


Unsuccessful applications

56 children were unsuccessful in their application for a preferred school. These children were allocated to either their designated area school or most accessible Wokingham school with places available.

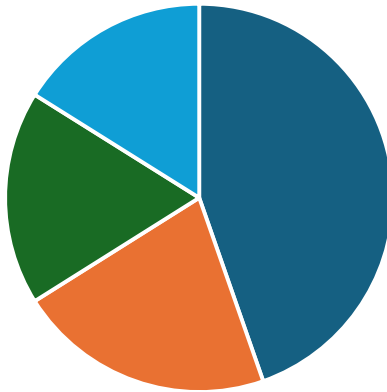

Designated area school included as a preference



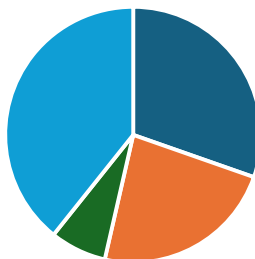
- Yes - DA school included as a preference
